2024-IDS-01, Expired QAP solution used

during annual certification on Instruments

On March 13, 2024, the Impaired Driving Section (IDS) identified that an expired ethanol QAP solution was used for one calibration level during annual certification of instruments ARKC-0055 and ARKC-0047. This resulted in tests being performed on instruments that should have not been deployed due to this issue. Both instruments were deployed from March 4 to March 13, 2024 at the Chelan County Regional Jail located in Wenatchee, Washington. During that time frame, four evidential tests were performed on ARKC-0047 and seven evidential tests were performed on ARKC-0055.

A total of eleven evidential tests were performed on the listed instruments while they were out in the field. Affected agencies: WSP, Chelan County SO, Douglas County SO, Wenatchee PD; Affected counties: Chelan and Douglas
