

### 111th Trooper Basic Training Class

On June 26, 2019, 41 new Troopers graduated from the 111th Trooper Basic Training Class and received their commission. They were sworn in by Associate Chief Justice Charles W. Johnson and handed their commission cards by Chief John R. Batiste and Attorney General Bob Ferguson, marking the beginning of their new careers.

WSP is proud of each and every one of our new Troopers for their hard work, dedication, and perseverance toward embarking on a career of Service with Humility.

### K-9 Graduation

WSP welcomed four new explosives detection K-9s to the Washington State Patrol's ranks. These K-9s are replacement dogs for current WSP handlers whose K-9s have recently retired.

These very special canines have endured 10 weeks and over 300 hours of intensive training with their handlers to prepare for the new careers ahead of them as explosives detection K-9s.

WSP has one of the largest non-federal K-9 programs in the country, with dozens of K-9s deployed throughout the state. Some work as narcotic detection K-9s, while others work specifically to locate explosives.









### 13th Commercial Vehicle Enforcement Officer Graduation

On June 11, 2019, 14 new Commercial Vehicle Enforcement Officers (CVEOs) graduated from the 13th CVEO Basic Training Class. Five Troopers also graduated from Commercial Vehicle Safety Alliance (CVSA) training, certifying them as Commercial Vehicle Troopers.

These new CVEOs and Commercial Vehicle Troopers will work hard to ensure compliance of the commercial motor vehicle regulations in order to protect infrastructure, prevent accidents, and save lives.

### Relaunch of El Protector Program

This year, WSP prepared for the relaunch of the El Protector program. This program was established in 2003, but continues to have a positive impact on reducing traffic-related deaths in the Mid-Columbia region through educational outreach and enforcement activities. Our current El Protector, Trooper Daniel Mosqueda, works to provide Hispanic/Latino community outreach education addressing the leading causes of fatality and serious injury collisions in Washington. He also works to build and promote positive relationships between law enforcement, the community, and our stakeholders. In 2019, the El Protector logo was redesigned, and in early 2020 WSP is releasing an El Protector website as well as launching an El Protector Twitter account.







### Two NASCIO Awards for Outstanding IT Projects

**Washington State Sexual Assault Kit Tracking System** was selected as a National Association of State Chief Information Officers (NASCIO) 2019 State Information Technology Recognition Award recipient, in the State Chief Information Officers (CIO) Office Special Recognition category.

The Sexual Assault Kit Tracking System provides accountability and efficiency in processing sexual assault kits in Washington State.

**Using UAS Technology in Collision and Crime Scene Reconstruction**, was selected as NASCIO 2019 State Information Technology Recognition Award recipient in the Emerging and Innovative Technologies category.

WSP's use of Unmanned Aerial Systems (UAS) has resulted in a significant reduction in road closure time and congestion associated with collision investigations, greatly improved investigative forensic documentation, and improved officer safety as investigations are conducted from the air rather than on the congested roadways.

## **Homeward Bound Program**

The Homeward Bound program, which is administered by the WSP Missing and Unidentified Persons Unit, uses the high visibility of commercial vehicles to increase awareness surrounding missing individuals. Since this program was established, in 2005, three children featured on these trucks have been recovered.

This year, we partnered with Kam-Way Transportation to place three missing persons: Teekah Lewis, Misty Copsey, and Alyssa McLemore on the sides of their vehicles.







## Legislative Proposals

The 2019 legislative session was successful for the WSP. We proposed the following three bills that were adopted by the legislature and enacted into law:

- **CDL Safety Belt Exemption (House Bill 1901):** Prohibits operators and passengers of a commercial motor vehicle from exercising the current medical exception to the requirement to wear a safety belt.
- Color of Stop Lamps on Vehicles (Senate Bill 5937): Requires all rear commercial motor vehicle lighting devices and reflectors, including stop lamps, to be red, except other signal devices which may be red or amber.
- Concealed Pistol License Federal Background Check (Substitute Senate Bill 5508): Clarifies the background check for an original concealed pistol license must be conducted through WSP Criminal Identification Section and must include a fingerprint background check through the FBI.

## **Emphasis Patrols**

Throughout the year, WSP conducted focused efforts and patrol emphases funded by the Washington Traffic Safety Commission (WTSC). These emphases continuously support our agency's goal of making people safe on Washington roadways.

#### **OFFICE OF THE CHIEF**


Under the direction of Chief John R. Batiste, the Office of the Chief oversees the day-to-day operations of the agency.
